### TERMS AND CONDITION

08. The appointment will be on Full Time Contract basis for a period not exceeding one year or till replaced by UPSC selected doctors, whichever is earlier, for the specified STATIONS only.
09. The Contract shall liable to be terminated by giving 15 days notice by either side. Without assigning any reasons, or if the Contract Medical Practitioner is mentally/physically incapacitated.
10. The Contract appointment shall not confer any right for regularisation or absorption in the post or right for continuity in service or automatic extension of the terms of contract.
11. The number of annual terms for engagement of CMPs is upto 12 terms on year to year basis or till attaining the age 60 years whichever is earlier and each term of engagement shall not exceed more than one year.
12. A candidate should not exceed 60 years of age as on 01.04.2018.
13. The Contract Medical Practitioner shall produce certificates of his/her character and antecedents from two gazetted officers of the Central/State Government.
14. Educational/Technical qualification: -
  - (c) **Specialist.** The candidate should possess MBBS with Post Graduate Degree/Diploma in respective subject/field as a specialist and should be registered with Indian Medical Council.
  - (d) **General Duty.** The candidate should possess MBBS Degree and be registered with Indian Medical Council.
