## DOCUMENT VERIFICATION OF PHYSICALLY HANDICAPPED (PH) CANDIDATES AGAINST E. N. NO. 02/2013 (Gr-D)

1. N.F.Railway had conducted written examinations against Employment Notice No.02/2013 (Gr.D) for recruitment in erstwhile Group –D posts in Pay Band – 1 of 5200 - 20200 with Grade Pay Rs 1800 on 02.11.14, 09.11.14, 16.11.14, 23.11.14 and 30.11.14 at Siliguri, Alipurduar, Coochbehar, Guwahati, and Tinsukia. Based on the marks obtained in the written test, Physically Handicapped (PH) candidates whose Roll numbers are mentioned below have been shortlisted for document verification (DV).

2. The Roll Numbers are **not** in order of merit.

3. **Cut off marks for DV**

4. Candidates will be allowed two block dates to complete their Document Verification process. **Candidates who are absent in the first date of DV will be allowed in absentee DV only under acceptable and valid grounds to be produced by the candidates.** DV will be followed by medical examination.

5. Call letters for DV are being sent to the candidates through registered post. In case the candidates do not receive the call letters despatched by post, they can appear in the DV by downloading the call letter from the website [www.nfr.railnet.gov.in](http://www.nfr.railnet.gov.in) five days before the DV. Candidates are requested to go through the instructions in the call letters for more information. RRC/NFR will not be responsible for late receipt of Call Letters on account of postal delay.

6. The purpose of calling 20 % extra candidates over and above the number of vacancies at the time of document verification is primarily to avoid shortfall in the panel and that merely calling a candidate for document verification does not , in any way , entitle him /her to an appointment in the railways.

7. Candidates appearing in DV must bring all the original certificates along with one self-attested copy of each certificate and four copies of recent coloured passport size photographs without coloured glasses. SC/ST/OBC/PH Certificates etc. should be current and invariably be in the format given in the employment notice. **Non-submission of requisite certificates in prescribed proforma will result in disqualification of the candidature.**

8. Candidates who have been disqualified/debarred by any of the Railway Recruitment Boards/ Railway Recruitment Cells on the ground of impersonation etc. should not appear in the DV even if call letters have been issued in their name.
9. Although utmost care has been taken to upload/publish the details correctly, RRC/NFR reserves the right to rectify any inadvertent errors or typographical mistake at any stage.
10. The candidature of the candidates called for DV is purely provisional. If it is found at any stage of the recruitment that the candidate does not fulfill all/any of the conditions of eligibility, his/her candidature will be cancelled and no appeal against such cancellation will be entertained.
