**Result of Online Examination of Special Recruitment Drive for Persons With Disabilities for erstwhile  
Gr. D Posts against CEN No.01/2015**

1. Online examination against CEN. No. 01/2015 conducted by Northern Railway (Nodal RRC) was held between 22.02.2016 to 26.02.2016 to fill up 16 posts in N.F.Railway earmarked for Persons with Disabilities (PWD). Based on performance in online examination, 19 candidates ( OH-8, HH-6, VH-5) with the following Roll Nos. are called for Document Verification (DV) on 27.07.2016 . The Roll Nos. are arranged in ascending order and not in order of merit.
2. The result is prepared on the basis of 'normalised marks' declared by the Nodal RRC.
3. 20% extra candidates over and above the number of notified vacancies have been shortlisted for Document Verification in order to make good any shortfall arising due to absentees, medical unfitness etc. The purpose of calling 20 % extra candidates is primarily to avoid shortfall in the panel and that merely calling a candidate for document verification does not , in any way , entitle him /her to an appointment in the Railways.
4. The call letters for DV will be available for downloading at the official website of RRC/GHY : [www.nfr.indianrailways.gov.in](http://www.nfr.indianrailways.gov.in) (General Info — Railway Recruitment Cell GHY).
5. Candidates appearing in DV must bring all the original certificates along with one self-attested copy of each certificate and four copies of recent coloured passport size photographs without coloured glasses. SC/ST/OBC/PWD Certificates etc. should be current. Non submission of requisite certificates in prescribed proforma will result in disqualification of the candidature. The candidates should come prepared to stay for more than one day in Guwahati for their medical examination.
6. Candidates who have been disqualified/debarred by any of the Railway Recruitment Boards/ Railway Recruitment Cells on the ground of impersonation etc. should not appear in the DV even if call letters have been issued in their name.
7. Although utmost care has been taken to upload/publish the details correctly, RRC/NFR reserves the right to rectify any inadvertent errors or typographical mistake at any stage.
8. The candidature of the candidates called for DV is purely provisional. If it is found at any stage of the recruitment that the candidate does not fulfill all/any of the conditions of eligibility, his/her candidature will be cancelled and no appeal against such cancellation will be entertained.
